








Overcoming Barriers

An Organizational Change Rapid Cycle Evaluation Method Developed by the Center For Medicare And Medicaid Innovation Serves as the Framework for the Program's Evaluation





Key Goal: Retain NPs in Rural and Underserved Areas to Provide Primary Care

Literature supports the need for post-graduate residency training that provides new NPs with the depth, breadth, and intensity of training that primes them for success as primary care providers in rural and medically underserved communities (CHC, 2022).


