## ALHeLA, Inc. Receives Federal Tax Exempt Status by Lisa Rains Russell ALHeLA 1990 Treasurer

In a letter dated June 5, 1990, we were informed by the IRS that ALHeLA is exempt from Federal income tax under section 501(a) of the Internal Revenue Code. Because ALHeLA, Inc. is a newly created organization, this is an advance ruling based on information about ALHeLA's operation from 1986-1989. The advance ruling period ends December 31, 1993. Within 90 days after that date we will have to submit the information of our operations during the advance period. Then, we will have a final determination! As long as our gross receipts total less

than \$25,000 we are not required to file any kind of income tax return between now and 1993.

I will be glad to send a copy of the determination letter on request. My telephone number is 348-1360.

Needless to say, I am relieved that this is behind us!

**ALHeLA Represented at Chapter Council Luncheon  
by Lisa Russell, 1990 Treasurer**

The Chapter Council of MLA invited presidents of state health library associations to attend a luncheon/sharing session during the MLA Annual Meeting in Detroit on May 22, 1990. Since she was unable to attend MLA, Beth asked me to serve as ALHeLA's representative.

The luncheon was held in a large banquet room and there were other types of discussion groups going on at the same time. Even the state groups were divided into two tables. At my table were representatives from Georgia, Tennessee, Virginia, Rhode Island, Vermont/New Hampshire, and Oklahoma. Each state representative shared a little bit about the history, organization and evolution of their state group. I have briefly outlined some of the information about each group. I really enjoyed this session. The only problem was that there was not enough time. It was gratifying to hear that we are already over some of the problems discussed and a relief to hear that others have gone through a stage similar to where we are now.

Virginia is in the earliest stage of development of a statewide group, although there have been several strong regional groups for many years. The regional groups united into a Council of Health Science Libraries just two years ago and had their first annual meeting this year. Virginia has applied to SEA/RML for a \$180,000 networking grant. SEA/RML is using Virginia's, North Carolina's and Puerto Rico's networking proposal in their funding requests to NLM.

The Rhode Island group is a consortium of mainly hospital libraries. They are in their 13th edition of a union list, have five meetings per year with one CE program/supper. There are 36 members. Officers are elected. Dues are \$15. They host the North Atlantic Regional Chapter Meeting on a rotating basis with other New England state groups.

The Georgia group has about 55 members both academic and hospital librarians. Their dues are \$5.00. They have an annual meeting and have met in conjunction with the Florida Health Libraries Association. They have developed an ILL workshop with syllabus and handouts which they are willing to share with other state groups.

The Oklahoma group's composition and evolution seemed to more closely parallel Alabama than any of the other groups. Like Alabama, Oklahoma is a predominantly rural state. The Oklahoma group was the oldest organization, having

been formed in the 1970's. The leadership is hospital librarian dominated due to the philosophy of the academic regional library. Academic librarians assist and advise but do not "run" things. The group meets in conjunction with the Oklahoma Hospital Association but does not have to pay dues to OHA.

The core leadership of the Vermont/New Hampshire group is academic librarians but the 60 members also include hospital librarians. They have two meetings per year and dues are \$20.00.

The Tennessee Health Sciences Library Association (THESLA) is anchored by hospital librarians and the evolution has been guided and encouraged by the Tennessee Hospital Association's Librarian, Judith Hodges. THESLA has co-hosted a Southern Chapter meeting and may co-host MLA in the near future.

**Czechoslovakian and Romanian Nurses Need Our  
Help**

The nursing leadership in both Czechoslovakia and Romania have issued an urgent appeal for help in increasing library holdings in their respective countries. Apparently during the Communist regime few resources were allocated to nursing scholarship. Thus there are virtually no library holdings. They are requesting old (or new duplications) periodicals, books, and audiovisual software.

The Alabama State Nurses' Association has been designated as a collection agency for these holdings until shipping. They are asking for your help in donating any library materials. The shipping date will be in mid October 1990.

#### **ALHeLA Heads For the Gulf Coast**

ALHeLA will hold its annual meeting at the Gulf Shore State Park Resort in Gulf Shores, Alabama on November 8-9, 1990. The theme of the meeting is "The Role of Computers in Medical Libraries." On Thursday, Jacqueline van de Kamp from the National Library of Medicine will conduct a CE course "TOXNET Made Simple". Ms. van de Kamp will also provide an update on NLM search services. A banquet and business meeting will be held on Thursday evening.

On Friday morning, Jack Smith, Reference Librarian at UAB will give a presentation on "The Expanding Role of Computers in Medical Libraries." He will also serve as a moderator for a panel discussion that will follow covering such areas as computer searching, Grateful Med utilization, OPACs and technical service aspects. In the afternoon, Lisa Russell will moderate a panel that will discuss various health science databases available on CD-ROM, including MEDLINE, CINAHL, Sport, ERIC, and PsycLit. Vendors of CD-ROM products will provide an exhibit of their products, including SilverPlatter, CD-Plus, Cambridge Scientific, and EBSCO. Barbara Shearer, Public Services Coordinator, Medical Center Location of the Biomedical Library, University of South Alabama, is in charge of the details.
