SERHOLD Update

The new DOCLINE is scheduled for release late Spring 2000. SERHOLD will be available for viewing some time prior to that. After its release, DOCLINE libraries will be responsible for updating their holdings in SERHOLD, online. ALHeLA has in the past orchestrated an annual OCLC tapeload to update SERHOLD. The National Library of Medicine will not be accepting another tapeload until late 2000. This presents issues for ALHeLA members who have updated SERHOLD and ALICAT simultaneously through OCLC tapeloads. Considering the current changes with DOCLINE and SERHOLD, ALHeLA members are encouraged to continue to update their holdings in ALICAT.

Access to the new DOCLINE, which provides access to SERHOLD and DOCUSER as well, requires Internet access. For ALHeLA members who do not have access to the Internet and would like assistance from the Alabama state coordinator with updating their holdings in SERHOLD, please contact Beth Wescott at the Regional Medical Library in Baltimore at 1-800-338-7657. Ask her to provide the state coordinator, Ellen Sayed, with access to your holdings in SERHOLD.

Member libraries with Internet access are encouraged to update their own holdings, but those who would like assistance in this first round of change, are welcome to contact the Beth Wescott and in turn Ellen Sayed. Libraries interested in assistance with updating SERHOLD, please copy the SERHOLD update form from this newsletter, use it to document your changes, and mail it to:

Other changes include update capabilities of DOCUSER and new LIBID. At this time, libraries can update their profiles in DOCUSER. Point your web browser to <http://www.nlm.nih.gov/docline/test/> Enter your DOCLINE password and ID, and you have access to DOCLINE, SERHOLD and DOCUSER from the same screen.

The new LIBID consists of a two letter state code, a one letter country code (U for USA, C for Canada, X for other countries), and the library's SERHOLD code. The Charles M. Baugh Biomedical Library at University of South Alabama's new LIBID is "ALUSOA". The old numerical LIBID will be mapped to the new one. This is especially applicable to our Loansome Doc customers.

The Birmingham VA Medical Goes Virtual

An executive decision was made by top management at the Birmingham VA Medical Center that the Medical Library should be converted to a "virtual" format. This change took place two weeks after the decision was announced, November 1999. The Medical Library was downsized and placed in a temporary location while awaiting renovations to the new location.

The library's paper collection consists mainly of management type books and training videos. The "virtual" library currently consists of: MD Consult; Harrison's Textbook Online; Ebsco Journals Online (4 databases); ProQuest Direct (4 databases); MicroMedex (full content); and a few individual journal titles. The databases are working well, but have left large gaps in our collection of resources. New NIH Clinical Alerts (3/14/00)

NLM has made new arrangements with the NIH Institutes to receive Web-based clinical alerts as they are issued. Links to the alerts are on the NLM web site at http://www.nlm.nih.gov/databases/alerts/clinical_alerts.html. Links to this page are available from NLM search systems like PubMed and IGM. Also, NLM will retain an archival copy of each alert for reference purposes

National Institutes of Health Launches *ClinicalTrials.gov* (02/29/00)

Database gives public easy access to information about research studies

(BETHESDA, MD) -- The National Institutes of Health today announced the launch of the first phase of a consumer-friendly database, *ClinicalTrials.gov*, with information on more than 4,000 federal and private medical studies involving patients and others at more than 47,000 locations nationwide. The new database may be reached at <http://clinicaltrials.gov/>.

Clinical trials are medical research studies that seek to evaluate the safety and effectiveness of new drugs, medical procedures, or other means of treating, diagnosing, or preventing diseases. This type of research helps investigators learn how different people respond to medications or other therapeutic approaches, and such investigations may lead to new or improved treatments. Trials are conducted when there is no proven treatment for a specific disease, or to test which treatment works best for a particular disease or condition.

ClinicalTrials.gov provides patients, families and members of the public easy access to information about the location of clinical trials, their design and purpose, criteria for participation, and, in many cases, further information about the disease and treatment under study. There are also contacts to individuals responsible for recruiting participants for each study.

Acting NIH Director Ruth L. Kirschstein, M.D., said, "Through this new database, NIH offers up-to-date information on promising patient-oriented research on hundreds of diseases and conditions. Most of the 4,000 clinical trials now in the database are funded by NIH

Institutes and Centers, and result from a long, fruitful partnership between NIH and the American people who support and participate in our work."

"If we are to continue making the giant strides in diagnosis, treatment, and cure of illness that marked the last century, we must have active participation in clinical trials by well-informed volunteers," said Donald A.B. Lindberg, M.D., Director of NIH's National Library of Medicine, which developed and administers the new database. "*ClinicalTrials.gov* is a resource that will benefit trial participants, researchers, health care professionals and, over time, the general public."

Dr. Lindberg noted that *ClinicalTrials.gov* may also be reached through the National Library of Medicine's Web site at <http://www.nlm.nih.gov> and through its consumer health information service, MEDLINEplus at <http://medlineplus.gov>. MEDLINEplus has extensive links to information about 350 diseases and health conditions, much of it from the NIH Institutes and Centers.

ClinicalTrials.gov grew out of 1997 legislation that required the Department of Health and Human Services, through the NIH, to broaden the public's access to information about clinical trials on a wide range of diseases by establishing a registry for both federally and privately funded trials "on drugs for serious or life-threatening diseases and conditions." (Section 113, "Information Program on Clinical Trials for Serious or Life-Threatening Diseases," Food and Drug Administration Modernization Act of 1997, Public Law 105-115.)

"The project is proceeding in several major phases," noted Alexa T. McCray, Ph.D., who directs the *ClinicalTrials.gov* project at the National Library of Medicine. "In the first phase we were interested in collecting information primarily about studies that are being funded by NIH, or that are being conducted right here on the NIH campus. With the release of *ClinicalTrials.gov*, the first phase is well under way. In the next phase we will include non-NIH sponsored trials from other Federal agencies and private industry."

ClinicalTrials.gov is a completely confidential Web site. No registration or personal identification of any kind is required. People who search the site will not be contacted by the sponsors of clinical trials or by anyone else.

Executive Committee Meeting
January 21, 2000

- I. Joan Lukins, President, called the meeting to order at 10:45am.
- I. Joan Lukins introduced the rest of Executive Board members for 2000. They are as follows: Past President -- Jie Li; Vice President / President Elect – Susan Deming; Secretary – Marian Morris; Treasurer / Bookkeeper – Lisa Russell; Members-At-Large – Yvonne Kozlowski, Valerie Gordon, Nelle Williams; By-Laws Committee – Pat McGee; Continuing Education – Martha Cook; Directory – Jan Burns, C.J. Bryant; Liaison – Tracy Powell; Membership – Carolyn Holmes; Synapse – Diane Williams; Union List Coordinators – Robert Avant, Ellen Sayed.
- II. The minutes of the August 1999 Annual Business Meeting were approved as written.
- III. Announcements: The Biomedical Library at the University of South Alabama is now officially titled the Charles M. Baugh Biomedical Library.
- IV. Old Business:
- A. Student Scholarship and Meeting Rate : Joan raised the question of whether this procedure needs to be formalized in the handbook. Discussion followed on various membership levels, etc. Carolyn Holmes, Pat McGee, and Lisa Russell will follow up on these issues and report back to the committee.
- B. Exchange Committee Removal : This committee was disbanded in 1996. The committee moved to remove this committee from the bylaws.
- C. ALHeLA Brochure : Joan expressed an interest in all members of the Executive Board having a small supply of brochures. We may need to re-print the brochure to have enough for this. The brochure needs to be updated instead of just reprinting the 1996 version. We need to clarify the membership categories and add information about the website. Carolyn and Lisa will discuss and report back to the committee.
- D. MLA CE Certificates : Joan is still trying to obtain the certificates from last fall's CE courses; they will be mailed to you.
- E. History for SC/MLA : Jie, Joan, and Pat Higginbottom will work on this.
- F. Copyright Training : Jan Burns has asked if we were interested in a copyright class of some sort. Judy Burnham suggested that we could perhaps do something with MASA. Lisa Russell reminded us that the "copyright librarian" is Laura Gasaway, a librarian and law professor at UNC. Joan suggested that we wait until the Internet copyright issues are more clarified, or just concentrate on print materials. Perhaps ALHeLA can provide an article to be printed in MASA Review. Anyone is welcome to provide an article; but it should probably be coordinated with Judy.
- VI. New Business:
- A. Web Coordinator and List Moderator positions for Executive Board inclusion : Joan suggested that we consider adding these positions. SC/MLA has a similar position on its executive board. A motion was passed providing that the website coordinator and discussion list moderator be voting members of the ALHeLA executive board; in the event that both positions are held by a single person, that person will have only one vote. Pat Higginbottom was appointed to the position.

- B. Retirements : Inez Pinkard has retired from her position at the VAMC in Tuskegee; and Bobby Powell has retired from her position at Carraway Methodist Medical Center in Birmingham. In addition, Lisa Rains Russell recently retired from the University of Alabama.
 - C. Spring Educational Opportunity with CDC Librarian : The committee discussed the options for this class. Sandra Bonzo from the CDC would teach the 2-3 hour session. Her proposed agenda is to explain the CDC's structure, public health vs. clinical medicine, and the content of the various CDC websites, with time allowed for questions and some hands-on practice. We will try to have this in a central location so that those from Huntsville and Mobile will be able to attend without requiring an overnight stay. It was suggested that we hold the class in Montgomery on the same day as the next board meeting or move the board meeting to coincide. The expenses should be minimal because the CDC librarian will provide this instruction without significant compensation. Joan, Martha, and Tracy will pursue the scheduling and CE credit for this educational opportunity.
 - D. Alliance Manual Update : Judy Burnham distributed a list of the pertinent dates for the update and the format guidelines. She also stated that there are still a few open sections that need volunteers to update the content.
 - E. 2001 Annual Meeting with Georgia Health Sciences Library Association : A motion was passed for ALHeLA to commit to participation in this annual meeting. The meeting will be in Columbus, GA in March or April of 2001. Pat Higginbottom reported that Cathy Woolbright is the GHSLA Program Chair for this meeting; Pat will work on the ALHeLA portion of the meeting. There will be separate business meetings. Because the meeting occurs so early in the year, we will probably select our Vice President earlier so that he/she can assist Pat with the conference planning.
 - F. Newsletter on the Webpage : A motion was passed to have *Synapse* included on the ALHeLA website with open access; we will continue to have a paper copy also. Another motion was passed to include the handbook and the bylaws on the website; neither the directory nor personal information will be posted.

VII. Treasurer's Report : Lisa Russell reported that our current balance is over \$8,300. The treasurer's report was approved as presented. We need to clarify the different types of membership.

VIII. Committee Reports:

- A. Bylaws : No report.
- B. Continuing Education : Martha Cook reported that she has been in contact with Lynn Fortney concerning plans for this fall's SC/MLA meeting in Mobile. Martha is an ex officio member of the Program Committee.
- C. Directory : Jan Burns reported that C.J. Bryant will assist with the institutional directory updates this year while Jan works on the rest of the directory. Jan distributed a new sponsorship form to be included in the Forms section of the directory.
- D. Liaison : No report.
- E. Membership : Marian Morris reported for Carolyn Holmes. The membership renewal invoices were mailed the last week of December. We currently have 26 members, 15 individual and 11 institutional. We have four new members -- Cynthia Cockerham (Lister Hill), Sue Loper (EBSCO), Rita Smith (Jacksonville State), and Tony Waterman (Carraway).
- F. Synapse : Diane announced that as usual, the deadline for submissions is two weeks after the meeting, February 4, 2000. She urged folks to get their submissions in on time.
- G. Union List Coordinators : Robert Avant requested that we continue to send our updates for the union list; AULS will continue to be an important resource since you can search by title. The offline serials union list products are as follows: paper, microfiche, 1600 bpi tapes, 6250 bpi tapes, IBM cartridges, and FTP through EDX or Product Services web. ALICAT is currently available in CD-ROM and on the Internet; the CD-ROM version may be discontinued after this year. Ellen Sayed reported on the changes that DOCLINE is undergoing.

- H. Web Coordinator / List Moderator : Pat Higginbottom reported that the website has a new look and some revised sections. She will be adding *Synapse* soon.
- IX. Review of 2000 Annual Meeting with SC/MLA : Susan Deming reported that the meeting will be October 20-24, 2000, at the Adams Mark Hotel in Mobile; room costs are \$93.00 per night for a maximum of four persons. Susan Deming and Tom Williams are co-chairing the Local Arrangement Committee. There will be a separate ALHeLA business meeting. A motion was passed for ALHeLA to donate up to \$2000 toward sponsorship of event(s) at SC/MLA, with specifics to be determined at the next executive committee meeting. This is ALHeLA's 20th Anniversary year; Joan and Jie will work on a special display for the meeting.
- X. Announcements : Joan will contact Stephen MacCall about this year's student award contest; this will be an agenda item at the next executive committee meeting.
- XI. Adjournment : There being no further business, the meeting was adjourned at 1:15pm.
