This class was enlivened by a rousing performance of “Head, Shoulders, Knees and Toes”, in Spanish, by the participants of the morning's other class. ALHeLA Business Meeting

Friday, September 13, 2002
Meeting, *Working Magic Through Communication*
Winfrey Hotel, Birmingham

1. **Call to Order:** Meeting was called to order at 12:30pm by Marian Morris, President.
2. **Approval of Minutes:** Minutes for the Executive Committee Meeting on June 14, 2002 meeting were approved as written.
3. **Treasurer's Report:** Treasurer's Report covering January 1 - September 11, 2002, was submitted by Martha Verchot and approved as written.
4. **Committee Reports:**
 - a. **Bylaws / Handbook** – No report provided.
 - b. **Directory** – Jana Slay provided new inserts for the ALHeLA Directory to members in attendance. Inserts would be mailed to absent members.
 - c. **Liaison** – No report provided.
 - d. **Membership** – Jodi Upton reported ALHeLA has 7 new members with a total of 53 members (52 regular, 1 student) for 2002. New members include Paula Barnett Ellis from Jacksonville State University, Barbara Clotfelter from Birmingham Public Library, Michael Fitts from UAB Lister Hill Library, Gerald D. Jackson from UAB School of Medicine-Huntsville, Jean Liddell from Auburn University, Sheila Snow-Croft, a University of Alabama graduate student, and Rita Wehby from UAB Lister Hill Library.
 - e. **Synapse** – Request made by Diane Williams for information and photos for publication in Synapse.
 - f. **Web Coordinator** – Report submitted by Pat Higginbottom that stated additions made to the ALHeLA website as updates of the following; the list of Officers, the Handbook, the student grant, and new information about the Scholarships for Librarians with Limited Institutional Support. The number of hits during the past 12 months totaled 1,286.
 - g. **Members-At-Large** – Geneva Bush Staggs requested that the membership take a critical look at The Scholarship for Librarians with Limited Institutional Support (SLLIS) application on the ALHeLA web page and submit comments. There were no applicants for SLLIS for this annual meeting.
5. **Old Business**
 - a. **2002 Annual Meeting** – Tracy Powell reported there were 37 total attendees for the annual meeting; registration for individual events was as follows : “Communication Mistakes Only Really Smart People Make” -- 18, “Spanish for Health Care Professionals” -- 8, “Communication as a Tool of Influence” -- 23, Speakers and Business Meeting -- 29. There was less vendor support for this meeting than for ones in the past.

6. **New Business**

- a. **Nominating Committee** – Marian Morris reported. Members of the 2002 Nominating Committee are Pat Higginbottom (Chair), Judy Burnham, and Sondra Pfeiffer. The 2003 Slate of Officers was presented and accepted. The new officers for 2003 are Geneva Bush Staggs, President Elect; Inga Moten, Secretary; Kay Fowler, Michael Fitts, and Susan Gambill for Members-at-Large.
- b. **ALHeLA Achievement Award** – Kay Hogan Smith was awarded the ALHeLA Achievement Award. In her absence, Tracy Powell accepted.
- c. **EFTS** – Toni Yancey, one of the region’s NNLN representatives, presented the electronic Fund Transfer System, Inc. (EFTS) as a document delivery network that was being recommended to member libraries. EFTS operates out of the University of Connecticut with over 600 participating medical libraries, mostly located in the northeast US. NLM will begin participation in January 2003. A pamphlet was included in each registrant’s packet.
- d. **Appreciation Award** – Tracy Powell presented Marian Morris with an appreciation award from the membership for her hard work and dedication during the past two years as President.
- e. **Thank you** – Everyone thanked Tracy Powell and Pat Higginbottom for their work on this annual meeting. Thanks also to Nancy Clemmons for being our conference photographer.

7. **Announcements** – No announcements were made.

8. **Adjournment:** The meeting was adjourned at 1:05 p.m.
